Registration & Technical Inspection

Registration and Technical Inspections will be held on Friday Aug 17th from 5:00 pm to 9:00 pm at River Boat Park. Registrations will be accepted up to 1 hour prior to race start on August 18th.

Registration entry fee is \$600. for early entries received prior to August 1st. \$750.00 after August 1st.

Each boat must be equipped with all the items required on the "Race boat checklist"

Regulations:

2012 U.I.M. rules for River Marathon Racing will apply.

Drivers, navigators, and crew must have a valid CBF membership.

All drivers are required to have a Pleasure Craft Operator's License.

All new drivers must have orientation course and driving test.

All race drivers require CBF medicals and CBF medical questionnaire.

All boats off step in the staging area.

Motors of A, CX, FX, FXV, will be subject to random testesing.

FX and CX boats will be weighed at the end a leg.

Race Maps

Maps of race legs are included in this package. Distances on maps are estimated.

Race Fuel

Race fuel will not be provided but is available from our Race Sponsor, Max Fuel Distributors, 780-778-2346, pre ordering is recommended.

Awards

Presentation of awards will be in the large shelter. 100% of entry fees will be awarded. Fast leg time awards.

Vehicle pass and access

During registration each team will be provided with 2 vehicle passes and 10 wrist band admission passes.

Parking

Scramble parking is in effect. Each team will be allowed to have only the race boat, its tow vehicle, plus a service vehicle within the Park.

General public will be required to park in the field outside the Park access and take the shuttle service to and from the Park.

Protests

All protests must be accompanied by \$500 fee and submitted to the Race Chairman.
